
# GLOBAL INSTITUTIONS DIVISION

The Global Institutions Division (GI) is SDC's competence and resource centre for multilateral development cooperation. The Division has the primary responsibility for development related intergovernmental processes, the dialogue with key UN institutions and International Financial Institutions.

The Division directly manages contributions to six multilateral priority organisations: the United Nations Development Programme (UNDP), the United Nations Children's Fund (UNICEF), the United Nations Population Fund (UNFPA), UN-Women and together with SECO the World Bank (WB) and the Asian Infrastructure Investment Bank (AIIB). To support the multilateral system in this regard GI engages in continuous political dialogue with multilateral priority organisations, contributing to their steering, emphasizing priority themes like Fragility Conflict Violence, gender equality, private sector development and partnerships, anti-corruption, as well as results orientation. With the same focus GI contributes to the reform of the UN's development system and the implementation of the International Development Association (IDA). Finally, GI supports the implementation of the monitoring and review mechanisms of the 2030 Agenda, as determined by the High-Level Political Forum.

### Main objectives

- Accelerate the implementation of the 2030 Agenda with a particular focus on the country level
- Ensure the accountability for the 2030 Agenda
- Improve policy coherence within Switzerland's multilateral Development Cooperation.

- Acceleration: Focus on implementation of UNDS Reform at country and regional level. Facilitation of the Quadrennial Comprehensive Policy Review (QCPR) 2020.
- 2. Accountability: Shaping and co-organization of the 3<sup>rd</sup> UN World Data Forum hosted by Switzerland in 2020.
- 3. Coherence: Identifying Swiss representations willing in "championing" a dialogue with the UN at country level on UNDS reform progress.
