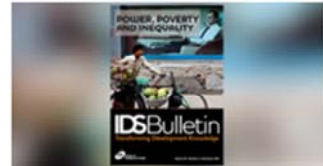
**An Economy for the 99%**

Yet, what is needed is a discussion beyond this figure which addresses the question how inequality can be effectively tackled and how we can keep on track with SDG 10. Ten years after the landmark 2006 issue that brought us the Powercube - a practical approach to power analysis that offers a way of confronting its complexity - the IDS Bulletin returns to the question of how to analyse and act on power in development. Funded by SDC as part of the Collaboration between SDC-QA and IDS, this issue focusses on the ways in which invisible power helps perpetuate injustice and widen inequalities.

Some 14 contributors, engaged in various areas of development work, come together to explore these dynamics and make recommendations for how to reverse the negative effects of invisible power through unsettling the normal and making visible the unacceptable. [Learn more »](#)

**Linking Poverty Reduction and Climate Change**

Natural disasters are a greater obstacle to ending global poverty than previously understood. This is the warning message of the latest report published under the World Bank Climate Change and Development Series. While traditional approaches reduce natural disasters to their monetary impact and represent only those wealthy enough to have something to lose, this report proposes a new measure for assessing disaster-related damages and suggests a "resilience policy" package in order to

At the recent World Economic Forum in Davos, whose mission was 'Improving the state of the world', income inequality was very much on the agenda. Yet inequality is about more than just income.
