

Sustainable production of cotton and cocoa (SFIAR Award 2021)





Financing for nutrition: Role of development banks

Amsalu Andarge Abate

What made you choose to work as an NPO at SDC?

I chose to work with SDC because of it allows me to work with vulnerable communities and with diverse stakeholders at national, regional and global level.

Who is your personal hero/heroin?

Nelson Mandela

What is the most important lesson you have learned from your work?

The lessons I am learning include: the new approach towards food systems, how nutrient and healthy foods are extremely important in African agriculture, and the needs of a multi-sectoral approach in programme implementation.

As population pressure continuously affects the natural capital and internal conflicts, drought, floods and COVID-19 has exacerbated food insecurity in the 55 African Union member countries, targeted, multi-sectoral and inclusive approaches are required to feed more people now and in the coming years. At this point the role of agriculture and food security experts are twofold: on the one hand to help political leaders better understand the current situation, and on the other hand to bring country specific solutions that support resilient agricultural development that can feed the existing population and the future generation. I have learned and I firmly believe that without taking into account the population pressure, it is challenging to address persistent food security problems. In most cases, the organisations have loosely considered populations in and across ministries, e.g., in Ethiopia.

Another lesson I have learned is the importance of engaging with the private sector in agriculture. As I perceive it, private actors are important players in agricultural value addition. In most low-income countries production is low and generates low value. Hence, bringing the private sector's expertise in mechanisation could allow to increase productivity and add value to agriculture in these countries, especially in the processing sector. So, our focus should be to encourage and incentivize the private sector to fully engage in food production.

Mr Abate Amsalu Andarge joined the Swiss Cooperation Office at the Embassy of Switzerland for Ethiopia, Djibouti, South Sudan and African Union as National Programme Officer for the Global Program Food Security on November 15, 2021. He holds a Master of Art in Rural Development and bachelor's degree in agricultural extension.

Mr Amsalu has more than twenty years of experience working in agriculture and marketing development in the public and the private sector in Ethiopia. He is proficient in value chain development, capacity building, cooperative support, inclusive marketing development and agricultural extension. He worked for the Government of Ethiopia (Ministry of Agriculture), Cooperative Agency, ACDI/VOCA, Oxfam GB, MEDA, Agriteam Canada, and SNV. His experience in linking smallholder farmers to lucrative local and international markets and enhancing capacities of government institutions, as well as farmer organizations are particularly to be highlighted. During his last assignment, Amsalu has worked for SNV's Livelihoods for Resilient Market-led programme, expediting the prolific relationship of development actors to the private sector.
