<b>Title</b>	<b>Gender, fragility &amp; politics (part I and II)</b>
<b>Focus and Key questions</b>	<p>Focus is on the integration of gender in PSG1 ‘legitimate politics’ - which is essentially contributing to SDG 16 - and deals with representation, participation and (local) governance processes. In fragile contexts, women often have very limited access to state institution and their relationship to these is often mediated through family, community or customary institutions. As a result, women are underrepresented in local politics and their needs and rights are not well reflected governance processes.</p> <p>This workshop wants to reflect on key gender issues in local governance, decentralization and political participation. Key questions are:</p> <ul style="list-style-type: none"> <li>• What are your experiences in integrating gender in local governance programs?</li> <li>• How women’s representation and participation in political decision-making, can be strengthened?
