Planning Future Activities of dlgn

What happened since Sarajevo

During the month of May, two important activities took place that will shape the future of the network. On the one hand, during a Workshop that took place on May 4, the **dlgn** Core Group took stock on the advancement of the network activities and developed orientations for the future of the network in the next nine to twelve months. On the other hand, on May 23, the SDC Board of Directors (BoD) adopted a proposal to support regional democracy movements in the following fields: direct democratic practices, representativity of democratic institutions (in particular those of women), pluralism and civil society, and state reforms which favor democratic practices.

Network Activities from mid 2011 to early 2012

It was agreed then, that the most immediate next steps until early autumn will be to finalize the products of the learning projects discussed in Sarajevo:

- The roster destined to help members to evaluate LGA tools
- Good practice recommendations on social inclusion for strategy and programme development
- The learning book website on support to municipal finances
- The study tour guidelines
- Elements of the election support capitalization to further being used in the policy debate on democratization support

Goals for the next period

The overall goals for the next period will be to further promote knowledge creation and learning on concepts and tools on dlg issues. The aims are that these concepts and tools are applied on SDC programmes and that they support the consolidation and implementation of SDC Policy on Decentralisation, Local Governance and Democratisation Support. In that regard, 5 specific objectives were defined.

- To introduce products, tools and policy recommendations to inform specific audiences (management, programme practitioners, partners). This will be done by organizing information events and by participating in meetings and workshops organized by different organizational units. Network members will remain updated via Newsmail and DGroups.
- To assist COOFs in the application of dlg tools in PCM and strategy development by elaborating an overview of planned revisions on sector strategies.
- To explore new topics for exchange and learning in particular South South/South-East. Via a pool of **dlgn** "experience carriers" and external experts, Peer to Peer learning will take place. A Learning Project on the "Role of Civil Society Organizations in Democracy, Citizenship, and Political Participation" will be launched, supported by the scientific backstopping (IDS). In Cooperation with Think Tanks and institutional partners, such as Int. IDEA and UNDP, topics of common interest will be deepened (democracy support, aid effectiveness, power, participation and citizenship) reflecting on SDC's own experiences.
- To analyse and elaborate tools on results measurement, in cooperation with the working group of the development partners (DPWG-DLG), with which we shall continue to offer joint training opportunities to SDC's and partners' staff. In the same context, an innovative concept on data collection and presentation of results based on authentic testimonies of stakeholders shall be elaborated.
- To implement and institutionalize the recent strategic decision of the BoD on future SDC democratization support.

Staff rotation in the dlgn

The major staff rotation SDC is undergoing during the summer of 2011 also affects the dynamics of the **dlgn**. One third of the active members of the Core Group are leaving HQ to assume responsibilities in country offices or with international organizations. For those who stay in Berne, this is of course a melancholic moment but at the same time, we are looking forward to cooperating with them from at field levels and to integrating new colleagues, who are returning to HQ with fresh practical experiences in their backpack. Most of the new colleagues will only arrive after the summer break. This somewhat delays concrete planning of activities, because the activity plans can only be based on the voluntary engagement of Core Group members in interesting tasks. Thus, we shall start concrete engagements around August.

2011 Status Report on Network Development

On July 4, 2011, SDC's Board of Directors (BoD) discussed this years' Status Report on Network Development. The Board is pleased to learn that networks on average are developing well and wants to keep the current architecture for the 2013-16 strategy period. The human resource shortage for thematic advising is recognized. The core Focal Point/network functions ask for 200-300% staff posts and additional thematic resources (part-time) should be created by the departments. The board reiterates its decision made on the spring of 2011 that network membership asks for at least a 10% time allocation in ToRs, and that multiple membership in different networks by one person is to be avoided whenever possible. Organizational units are encouraged to review their staff's membership in networks: membership is to follow a competence-need- and-contribution logic, and not an institutionalrepresentation-logic. The Knowledge and Learning Processes Division KLP is mandated to propose measures to strengthen thematic quality orientation and a concept on how to measure organizational learning. The Board takes account of the malaise expressed by Focal Points and Theme Managers regarding the low priority of thematic competence in certain processes, especially the strategy formulation process. Networks are encouraged to challenge the board with thematic discussions more frequently and more strongly. The Board mandates KLP to draw up a proposal for a new network on "International Cooperation Craftsmanship", which will address the Methods of International Cooperation, Management, and How to conduct policy dialogue, among others. Aid, Accountability and Democratic Governance

Synthesis of Guidance and Key Policy Messages on Aid, Accountability and Democratic Governance: OECD-DAC-GOVNET Programme on Improving Support to Domestic Accountability

This work represents a collective effort of the OECD-DAC Governance Network in collaboration with partner institutions such as: parliaments, civil society organisations, political parties, and the media. It explores citizen-state relations and seeks to understand the impact of aid on domestic accountability. It provides direction on how to take more strategic approaches to support accountability systems (budgeting/service delivery in sectors) and provides principles for democratic governance in areas of electoral assistance and support for parliaments, the media, and political parties, among others. It is based on country case studies in Mali, Mozambique, Peru and Uganda, a range of literature on donor innovations in this field since mid-2009 and a series of high-level dialogues on trends in support to accountability. The Management Group on Aid and Accountability will follow through to further develop and then finalise the document and related plans for its implementation, following the discussions and reviews among GOVNET members that took place in June 2011. GOVNET members aim at drawing out key messages from this work and reflecting on their own internal efforts to discuss at the High Level Forum on Aid Effectiveness in Busan that will take place at the end of 2011.

30 years of Decentralisation in Madagascar: Views from an "inside participant"

Upon invitation of the **dlgn**, the Bernese social anthropologist Gion Cabalzar presented his analysis of the decentralisation process in Madagascar: its ups and downs, and the political implications and motivations, which lead to the reforms of the last 50 years. After having lived in Madagascar for 30 years, his insights as a "participating observer" have revealed interesting aspects, which might merit further analysis. The fact that local governments in Madagascar only manage some 3% of public expenditures - the rest remaining in the competence of central authorities and administration - may not surprise those familiar with other (African) countries. More surprising may be, however, that in a generalized context of corruption and political control ambitions, the Malagasy authorities have adopted a "revolutionary" law on land property management, attributing the competence to issuing land titles to local governments, referring to traditional law. The event was organized on June 1, in Belgrade by the Ministry of Public Administration and Local Self Government. Upon consideration of public proposals, the draft Law will be proposed for adoption by the Serbian government, and will eventually enter procedure in the parliament. The model law was prepared through the programme Citizens' Participation in Serbia supported by SDC and implemented by the Standing Conference of Towns and Municipalities. Inputs from Swiss experts and parliamentarians helped Serbian lawmakers to enrich contents of the draft law. //Community Activities/dlgnews. This study is the result of the brainstorming session of the COOF with its partners and consultants. It is a qualitative analytical baseline of the situation of women in the new local political landscape in Bangladesh. It addresses the fact that little was known about the profile, interest and weight of women council members at Upazila (sub-district) levels - around 450 units in Bangladesh. The study has been carried out during the preparatory phase of a UNDP project: the Upazila Governance. The results of the study are being discussed within the relevant networks in Bangladesh, and with key NGOs. It is planned that in the framework of this UNDP Project, national debate on dlg using the "gender lens" is encouraged. It is also expected that the new UNDP project team gets inspiration from the study findings to better frame and focus project activities.

Asian Regional Conference on Effective Local Governance, Accountability, Participation and Inclusion
