The training will be organized in the framework of the Train4Dev Initiative and will be constructed on the basis of the training modules used in the pilot course organized last January in Brussels, which was attended by 11 members of the dlgn. In-country training events

The DeLoG offer will comprise training courses delivered upon request by dlg sector groups (issued by their lead agencies) jointly with the partner governments. In the in-country training events, theoretical inputs on various aspects of decentralisation will be complemented by case studies highlighting mainly situations from the host country. The courses will be open to national partners and staff of development partner agencies. This promises to present unique opportunities to discuss the national reform agenda and to develop common views. The organization of in-country courses will be provided by the sector group in the partner country according to the DeLoG rules inspired by T4D experiences, and the trainers will be provided by the DeLoG subgroup.

Generic Modules


The generic modules tested in Brussels will also be used for introductory courses to dlg in an environment marked by increasing harmonization and coordination efforts. The introductory courses, which will be organized by different donors, will be open to all staff of the 26 development agencies, members of the DeLoG. This setup ensures learning and exchange about approaches and modalities of different partners.

E-learning courses

The third training activity, which was discussed by the subgroup, is the organisation of E-learning courses. A GIZ specialized unit will look into that question and examine the advantages and disadvantages of this option to be discussed at the next subgroup meeting, which will be held in Copenhagen around November/December of this year.

It is generally assumed that successful decentralization makes government more accessible, accountable and responsive to women. However, it is not always easy for women to enter the local political arena still dominated by men. Women are confronted with a locally powerful combination of (often very patriarchal) social and political forces which hinders them to be elected or to take an independent position and make their voices heard. Moreover, research has shown that women's participation in local government often contributed to reinforce their traditional roles as caregivers and homemakers, rather than helped them to gain more influence over the decisions that affect them. In many cases, substantive gains in balancing men's and women's interests in economic and social development and protecting women's rights were made at national level and not at local level.

Decentralization and local governance do have important potentials from a gender equality perspective, if certain elements are considered. Among other things, women need to be organized and represented politically, at local and national level, with a view to join forces and make their voices heard. Best results on gender equality are achieved when local actors can link up with the existing national frameworks on decentralization and gender equality. Moreover, women are not all the same: Their belonging to different social groups may shape their access to decision-making, services and resources even more than their gender identity, and if local governance is to have a real impact on gender equality, it has to take a differentiated approach.

Gender equality does not simply equate increased representation of women in local government or increased presence of women in project implementation. This is a good starting point, but not sufficient. It has been observed that in many countries, women pay the price for scarce resources available at local level. For example, the introduction of user fees for local services in education, water and health can have a significantly stronger impact on poor women than men. If decentralized governance aspires to respond effectively to the needs of the local population (and not only to local elites), it has to be gender sensitive, understanding and balancing the concerns of both women and men of various social groups, and design local policies and public spending accordingly. Thus, gender equality is not only an aim in itself, but a building block of effectiveness of local governance – and an indicator for local governance performance.

Member review: "Learning about Federalism and Fiscal Federalism" Two educational videos and a Facilitator's Guide.

Since the end of the Second World War, the number of federations in the world has increased from 4 to 28 – comprising 40% of the world's population in 2011. Apparently, there is something very attractive to this form of public administration of countries. As the name explains, the Forum of Federations thinks that this is indeed the case. They produced two educational videos and a facilitator's guide that can help convince the rest of the world of this fact.

The DVD on Federalism starts quietly with introducing basic characteristics. However, several video seminars later, you need to change your glass of wine for some paper and a pen. By then, the basic notion of a government with constitutionally enshrined different levels that have shared sovereignty is mixed with presidential and parliamentary systems, with the role of regional or national parties, with strong or weak constitutional courts and with the raising, spending and sharing of taxes. The DVD on Fiscal Federalism goes more into detail on this last issue. It touches upon vertical equity (between federal government and constituent units) and horizontal equity (between constituent units). It explains dualist federations (where federal and constituent units administer their own legislated programs) and integrated federations (where the constituent units administer federal laws in specific areas like health care and education). Is also has a module devoted to collecting revenues and managing transfers.

The unique selling point of the video is however its combination with the Facilitator's Guide. This transforms the introductions into a powerful and accessible educational tool. The guide allows going beyond self-paced courses (like the sofa-course your critic took) and using the DVD for guided group discussions. The Facilitator's Guide is very complete and detailed. It gives tips for planning the courses, suggests questions for guiding group discussions, gives tips for logistics and type of materials needed, and contains evaluation forms, including transcription of the videos.

"Learning about Federalism and Fiscal Federalism" is not only suitable for government officials, researchers, students, journalist, but also for development professionals in the field of public administration reform that would like to put their work into perspective (even if they work in a unitary state). A great strength of the videos is the wealth of examples that are used from federations around the world. It illustrates the theory and makes readers aware of the enormous diversity of federations worldwide. It is regrettable that the videos and the Facilitator's Guide are - for the moment - only available in English. This limits its usefulness for training purposes in developing countries. But that is only a blemish in what is generally a complete and interesting introduction to federalism.

FORS - Swiss Centre of Expertise in Social Sciences

FORS is a social science research and data infrastructures centre servicing the national and international scientific community. It is responsible for some of the major Swiss national scientific surveys, like the Swiss Household Panel (SHP), the national election study SELECTS, the Swiss contributions to the European Social Survey (ESS), the International Social Survey Programme (ISSP) and the European Values Study (EVS). FORS also documents, stores, and gives access to a large amount of social scientific data produced in Switzerland, and it serves as an entry point for researchers to access microdata of the Swiss Federal Statistical Office (SFSO). LoGIn - Facebook becomes a Platform for Exchange Amongst Village Council Leaders in the Western Part of India

An innovative course on Decentralization and Local Governance making use of "Technology Enhanced Learning Process Enablers" (TELPE) was carried out as a pilot in the Western part of India between December 2010 and April 2011. It was supported by the Local Governance Initiative South Asia – LoGIn, the dlg knowledge sharing project of South Asia Division. The 3 module course was offered to 40 elected members of local governments in Kutch (a district in the state of Gujarat). The course was significantly different from most mainstream capacity building efforts invested in by the state and nongovernmental actors in (i) its use of ICT tools, (ii) the emphasis on perspective building (on aspects such as benefit sharing) as much as on skills improvement, (iii) its emphasis on building theory from the participant's own experiences and finally (iv) promoting experiential learning through learningby-doing exercises that complement the classroom sessions. The course was significantly popular for the skills it imparted on the use of social networking tools to enhance experience sharing and peer learning. Besides using Facebook, Twitter, Picasa and You-tube, the trainees are presently engaged in follow-up exercises such as working out the village development product to assess potential for own-revenue-raising, as well as for better negotiating on benefit sharing arrangements. Proyecto en arranque: "Apoyo Directo para Inversiones Municipales" (APIM) en Honduras y Nicaragua

El "Proyecto de Apoyo Directo para Inversiones Municipales" (APIM) se enmarca en la estrategia de la Cooperación Suiza de apoyo a la gobernabilidad local en Centro América. Este proyecto apoya los procesos de descentralización que Nicaragua y Honduras han emprendido, desde muchos años atrás, contribuyendo a la reducción de la pobreza en zonas rurales. Basándose en la modalidad innovadora de apoyo presupuestario mediante la transferencia de recursos al presupuesto municipal tiene el propósito de facilitar la ejecución de los Planes de Desarrollo Municipal (PDM) y de los Planes de Inversión Multianual (PIM) y otras iniciativas estratégicas orientadas al fortalecimiento de la transparencia institucional y la democratización de procesos de desarrollo local. El objetivo principal del proyecto es de "contribuir a mejorar las condiciones de vida y acceso a servicios de calidad de la población que vive en mayores condiciones de pobreza" en 20 municipios de Honduras y en 12 municipios de Nicaragua, llegando a aproximadamente 720.000 personas. Los componentes del proyecto son de mejorar: a) las capacidades en los procesos de gestión financiera y control interno municipal; b) la calidad de las inversiones apoyando las capacidades municipales de gestión del ciclo de proyectos de inversión municipal; y c) los procesos de gestión participativa y auditoría social de los recursos, para asegurar su apropiación por la población.
