## Looking back at the F2F Meeting in Aswan

Around **80 members** of the **dlgn** participated in our third F2F organised in Aswan, Egypt from May 12 -16: three and half days of intensive discussions of SDC thematic issues and experiences in working on development projects related to governance, decentralization and democratization.

The first day started with a discussion on hot issues in democracy and governance. Moving away from the institutional and thematic context to realities on the ground, a panel discussion grouping experts from Egypt, Kirgizstan and Macedonia provided participants with a glimpse of the complexity of working on governance and democracy. In the afternoon, participants joint different master classes offered by IDS experts and dlgn members on a wide variety of issues: political economy, casual chain approach, decentralization and peace building, Egypt's unfinished revolution, decentralization and social cohesion, and informal local governance.

The second day addressed aspects related to the drafting of governance strategies. The first session presented the findings of the learning project on "citizens' participation & accountability: what is good practice and what needs to change?" The second input introduced the political economy analysis (PEA) and the power analysis. In the afternoon, the theory was tested by practice as four SDC offices presented their experience in using PEA. The final input of the day was on key issues of quality assurance.

On the **third day**, the findings from the learning project on **outcome measurement in local governance programs** were presented. During the afternoon participants joined several roundtables, with Egyptian politicians including members of Parliament, about the Egyptian transition process.

**The forth day** was devoted to looking ahead and identifying priorities of **dlgn's** future work:

- Already existing tools like local governance assessment are useful to improve steering and reporting and do have the potential to increase impact of programs. However, they are not yet applied to their full potential, and the dlgn should make efforts to broadly introduce them.
- Improve our **competences** in analyzing **power relations** and do coherent **political economy analysis**, in order to better adapt SDC's strategies to local contexts (best fit instead of general best practice). This calls for strengthened offers in training and capacity development.
- Analyze the role of so far 'ignored' actors like political parties and legislative bodies. According to their potential as drivers and restrainers of democratic change, cooperation strategies should be developed taking these actors into account (members ask for guidance on that).
- Invest more in **innovative approaches on citizen-led-accountability**. Visual methods presented by and the recommendations issued from the learning project "civil society participation and accountability" show how SDC can go beyond its practice on policy and on practical cooperation.
- Municipal funds are crucial for improved local governance. Fiscal decentralization including PEA and capacity development has a central place in all strategies on DLG and must be adequately considered.
- Regarding **assessing results**, lessons from the learning project "outcome measurement", including a set of indicators should be further used in future.
- On a multilateral level, Governance must be treated as a "strategic enabler", in particular in the Post-2015-MDG agenda. The close cooperation of dlgn to the DeLoG can be used as a transmitter of these policy quests.

## **News from DeLoG**

### **Post-2015 Global Governance Consultation**

From 28 February to 1 March, the final meeting of the Post-2015 Thematic Consultation on Governance took place in Midrand, South Africa, hosted by the Pan African Parliament and co-chaired by UNDP and UNHCHR. Over 200 government officials, civil society representatives, governance experts and practitioners came together to identify key areas and themes of governance, and to explore how governance and accountability can be integrated into the post-2015 development agenda. Local governance and local development were identified as one of eight pre-selected topics that were discussed in roundtables. The DeLoG secretariat was amongst the selected panellists for this session. This presented an excellent opportunity to launch and disseminate the latest DeLoG working paper. The outcomes of the meeting will feed into an overall report, which will be used to engage with the UN-HLP, the Open Working Group on Sustainable Development Goals (SDGs) and other key processes in preparation for the General Assembly's Special Event on the Millennium Development Goals (MDGs) in September 2013 and beyond. ## Agreement signed with Swiss Development Cooperation for the cofunding of DeLoG and its secretariat in Bonn

On February 18th, "pen has been put to paper" at SDC headquarters in Bern to formalise the SDC contribution to strengthen the DeLoG network and its secretariat from 2013- 2015 with an annual contribution of approximately US\$ 300'000. A substantive part is directed to the implementation of the DeLoG/learn4dev joint learning programme. This is an important milestone in the life of the Development Partners Working Group on Decentralisation and Local Governance (DeLoG) towards a more collectively owned and widely engaged network. # Equity, Accountability and Effectiveness in Decentralization Policies in Bolivia

IOB Study (2012)

The Policy and Operations Evaluation Department (IOB) and Dr. Jan Willem le Grand of the Netherlands Ministry of Foreign Affairs have recently published a study on decentralization policies in Bolivia. Based on longitudinal data (collected for the period between 1996 and 2011) this study follows a micro level approach to unravel decentralization policies in Bolivia. The study compares different municipalities and goes down to the level of individual communities to get an understanding of the implications for questions of access, equity, participation and accountability. ## Cost-effectiveness of dldp interventions through the grant fund

The purpose of this report was to measure selected indicators on the costeffectiveness of the dldp 2 grant fund, in the framework of a broader effort of SDC to address cost-benefit of its projects in different countries. The report analyses two main interventions related to the grant fund: 1) the cost – effectiveness of the projects co-financed by the grant fund; and 2) the cost effectiveness of the technical assistance offered by dldp in the form of capacity building/coaching for the LGU-s related to project cycle management and procurement. Based on the indicators selected, one can conclude that the dldp grant fund has made a substantial contribution towards achieving one of the project outcomes related to the strengthened capacities of the LGU-s in Shkodra and Lezha Regions to perform better services. The analysis of the indicators shows that further efforts are needed in some areas in order to sustain the results achieved. This report of dldp on cost – effectiveness on grant fund management presents an insightful content and a methodology that might be interesting for dlgn members. 
