In the frame of the Convention on the Elimination of All Forms of Discrimination Against Women (CEDAW), which obliges State Parties to actively combat discrimination against women, this tool follows SDC's mainstreaming approach (SDC gender equality policy, Toolkit "gender in practice"), to reduce inequalities between women and men. It can be used

- to collect gender specific information on the context where resources are allocated (credit proposals)
- to mainstream gender systematically from the very beginning of planning processes of any intervention,
- to report the gender performance to the gender desk at the headquarters for knowledge management and statistical requirements.
