





Gender Baseline Assessment in Lao Upland Rural Advisory Service (LURAS) project

Objective: - Service coverage on agriculture extension

- Data will be used as a base line information
- Methods: Interview with agricultural extension staff in two districts - Interview with female and male farmers in six villages
- Key data: Profile of villages and farming system
 - Service received and satisfaction levels
 - Sex-disaggregated data in different types of agriculture extension services
- Utility: Gender raise awareness among stakeholders
 - Targeting more services to female farmers/female head of households
 - Project monitoring and impact evaluation.

Key challenges and recommendations

- More male than female farmers have accessed to different types of agriculture extension service.
- Lack of sex disaggregated data in many farming activities (no record).
- Low gender awareness among key project partners.
- Lack of gender knowledge and analysis skill among staff (highly depended on consultants).
- Need to improve the capacity of project partners to collect data and do more gender analysis for future extension activities.
- Need to enhance the project monitoring system from gender perspectives.
