Political Economy Analysis of selected sectors in Zimbabwe

1 Background

The Swiss Cooperation Programme for Zambia and Zimbabwe 2023-2026 outlines 3 key areas of engagement, namely 1) increase food security and unlock economic opportunities, 2) strengthen health service delivery and shock responsive systems for resilience, and 3) improve public sector accountability and citizen participation.

In the past, Switzerland's engagement in Zambia and Zimbabwe followed a regional approach and focused primarily on improving food security and access to Sexual and Reproductive Health and Rights services and prevention of HIV/AIDS amongst youth. The new two-country Programme approach provides an opportunity to build upon results and lessons learnt from earlier regional interventions, and to deepen and extend cooperation in specific sectors, including on governance.

With governance as a stand-alone outcome area of the 2023-2026 Swiss Cooperation Programme, Switzerland aims to address fundamental shortcomings in public sector governance, increase social cohesion and the overall impact and sustainability of Swiss interventions in Zimbabwe and Zambia.

In line with SDG 16, Switzerland understands effective, accountable and inclusive institutions on the one hand, and peaceful and empowered societies on the other hand, as key enablers for sustainable socio-economic development to realize the 2030 Agenda. Globally, SDC's engagement on governance is centred around five pillars: i) Promoting democratic governance, participation and accountability, ii) Supporting decentralisation and well-functioning multi-level governance, iii) Combating corruption on all levels, iv) Responding to governance opportunities and challenges arising from digitalization and v) Strengthening governance as a lever and transversal theme.

In all these pillars, Switzerland aims to address governance issues through a systemic and political approach that takes into account foundational factors, structures, processes and actors and gives consideration to underlying power dimensions.

2 Programme Context

Through its new Cooperation Programme, Switzerland aims to address governance from both the supply as well as demand side:

- Outcome 3.1: Public institutions effectively deliver services in an accountable way and in respect of human rights: Switzerland's support aims to strengthen public institutions at various levels to increase capacities, accountability and inclusiveness of public institutions to effectively deliver on their mandates.
- Outcome 3.2: Citizens, specifically women and youth, increasingly participate and influence decision-making: Switzerland's support aims to strengthen civil society and civil society organisations to promote participation and inclusion at all levels (from household, to community and national structures) with a focus on leaving no one behind and empowering vulnerable and marginalized groups, namely women and youth.

In the past, both SDC and the Ministry of Foreign Affair's Peace and Human Rights Division have supported governance interventions in Zimbabwe. They addressed a broad range of

issues including Social Accountability, Reconciliation, Human Rights, support to independent Commissions and the General Elections and targeted different stakeholders from central and local government and civil society. With the establishment of a dedicated Governance Outcome, SDC aims to prioritize interventions that tackle the root causes of governance failures, strengthen participation, accountability, transparency and inclusion and bring about tangible results while capitalizing on existing knowledge, networks and relationships. Governance interventions will first focus on Zimbabwe and will include Zambia later on.

In order to gain a better understanding of the governance system, existing and possible interventions in the governance sector in Zimbabwe, SDC engaged in a governance mapping exercise in the first half of 2023 which was followed by a validation Workshop with Embassy staff and selected partners to identify potential areas of interest to be further pursued.

3 Scope and objectives of the political economy analysis

The proposed political economy analysis is one of several steps towards the design of SDC's new Governance Outcome programme and shall provide the analytical framework from which pathways and operational implications will be derived. It shall complement the preceding governance mapping exercise and shall illustrate the ways in which political and economic power is constituted, exercised and contested in selected areas. It shall also highlight how the two dimensions are intertwined and the challenges this might entail when working on Governance. In this sense, it shall give insights into how change might happen and how a Swiss intervention might contribute to creating spaces and enhancing peoples' capacities to effect change.

The PEA shall focus on the following two key areas and provide insights into relevant foundational factors, structures, processes and actors, their interdependencies, roles, power, interests, willingness and capacities for change:

- 1. Decentralization/Devolution Reform and Local Governance Systems
- 2. Civil Society Sector with a focus on Civil Society Organisations operating at the local government level, including media organisations

The analysis should put a particular focus on youth and women as actors/changemakers, and gender aspects and dynamics must be explicitly looked at.

More specifically, the analysis shall address the following aspects in the two key areas:

Analysis of foundational factors:

Including national, subnational and international socio-economic and power structures, patterns of inclusion/exclusion within state and society; fault lines of conflict; reach, authority, and legitimacy of the state

Analysis of the "rules of the game" and political settlements

Including inclusiveness of political and economic bargaining processes, competition for political power, the role of social institutions and social communication networks, the role of women and reasons for failure of previous reforms

Analysis of actors and agent

Including their interest, relationships, capacities, leadership incentives and disincentives for changes.

Pathways of change

Including local incentives/pressures for positive change, scope to promote development, reform space, lessons learned from previous progammes and tactical pathways for change.

4 Methods and Approach

To address the study questions, the proposed methodology should include a combination of quantitative and qualitative approaches, including a desktop review of existing governance reports and programme reports/reviews and interviews with key stakeholders in Zimbabwe. See *9. Stakeholders* for a non-exhaustive list of potential stakeholders to engage.

5 Deliverables

- Deliverables 1: An inception report which contains the methodology, approach, assessment questions, data collection and data analysis methods, suggested list of key informants and key stakeholders.
- Deliverable 2: **Presentation of preliminary findings:** develop and present a PowerPoint presentation showing preliminary findings to the programme's key stakeholders. Comments made by the key stakeholders will inform the draft report.
- Deliverable 3: A draft report which should follow the following structure: Introduction, Methodology, Analysis, Conclusions, Recommendations and Annexes to be shared with key stakeholders for comments. The report should not exceed 20 pages, Arial 11 excluding the annexes.
- Deliverable 4: **Final study report** incorporating all comments received and a **final Power Point Presentation** summarizing the report.
